COVID-19 Operation Plan

The Michigan Department of Health and Human Services (MDHHS) issued a new emergency order regarding gatherings and face masks, effective on November 18, 2020, to prevent the spread of COVID-19. The Department of Building Services will continue to conduct Building, Electrical, Mechanical, and Plumbing inspections; however, inspections will be **limited** to those required to move construction forward and inspections where a wide and clear path can be provided to maintain safe distancing. Property maintenance inspections for rental properties remain suspended until further notice. All job sites are required to adhere to all provisions of Executive Order 2020-70.

The Administrative Office remains closed to the public, and we will only permit in-person meetings through previously scheduled appointments.
